To make your election, please duly complete and sign the Reply Form and return it to Link’s unit registrar (the “Unit Registrar”), Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen’s Road East, Wanchai, Hong Kong by post using the mailing label provided at the bottom of the form. The Reply Form may also be downloaded from the website of Link or the website of HKEx.

Please note that if we do not receive your duly completed and signed Reply Form or receive no response from you indicating that you object to receiving corporate communications by electronic means through Link’s website on or before Monday, 22 July 2019, you are deemed to have consented to receive all future corporate communications by electronic means through Link’s website instead of receiving them in printed form. In that event, when Link makes a corporate communication, a notification letter of the publication of corporate communication on Link’s website will be sent to you by post or by email (if you have provided us with your email address).

Notwithstanding the selection you have made, you are entitled to change your choice of language and means of receipt of all future corporate communications of Link at any time by giving reasonable notice to the Unit Registrar in writing at the address shown above, or by email to linkreit@computershare.com.hk. Even if you have chosen (or are deemed to have consented) to receive all future corporate communications by electronic means through our website but for any reason you have difficulty in receiving or gaining access to any corporate communication(s) on our website, the relevant corporate communication(s) in printed form will be sent to you promptly upon your request free of charge.
